1. Introduction

Parul Innovation and Entrepreneurship Research Centre (PIERC) successfully organized **Startup Nivesh 1.0**, a two-day flagship investment initiative designed to connect early-stage startups with active investors and funding partners. Out of **300+ startup applications** received nationwide, **30 promising startups** were shortlisted for the final **investment pitching round** held in the presence of **30+ investors and venture partners**.

2. Objectives

- To provide a dedicated investment platform for startups seeking early or growth-stage funding.
- To facilitate **direct 1-on-1 interactions between founders and investors** for meaningful funding discussions.
- To encourage the signing of investment commitments ranging from **₹20 Lakhs to ₹1 Crore**.
- To enhance the startup investment ecosystem through mentorship and collaboration.

- To promote Parul University's vision of fostering innovation and entrepreneurship.

3. Program Details

The event was structured around intensive engagement between startups and investors through multiple sessions:

- **Startup Pitching Rounds:**
30 selected startups delivered concise, impactful presentations highlighting their business model, traction, scalability, and financial needs.

A unique highlight of Startup Nivesh 1.0 was the **exclusive 1-on-1 pitching sessions**, where **each startup founder interacted directly with multiple investors**. This personalized format allowed founders to receive specific feedback, explore diverse investment options, and negotiate funding terms more effectively.

- **Investor Panel Discussions:**

Prominent investors shared their perspectives on funding trends, evaluation metrics, and emerging sectors for innovation.

- **Networking and Collaboration:**

Open networking sessions facilitated meaningful connections between entrepreneurs, mentors, and investors, creating long-term opportunities for collaboration and growth.

- **Investment Announcements:**

The event culminated in the signing of **41 Letters of Intent (LOIs)** between investors and startups, with a **total funding commitment of ₹18.4 Crore**, marking a major success for the inaugural edition.
